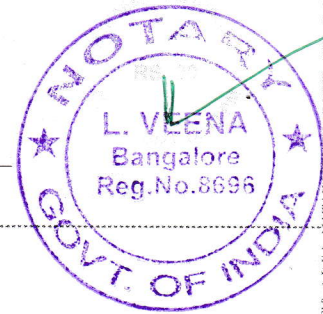

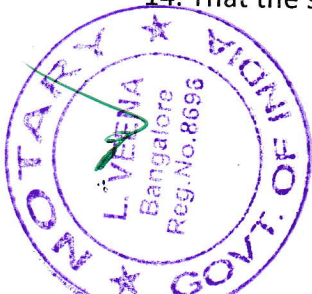

**AFFIDAVIT**

I, **Pramod Ramdas Kamat**, Son of Late Shree Ramdas Mukund Kamat, aged 71 (years), and President of Sri Vidya Educational Trust, running Romasha International School, do hereby solemnly affirm and sincerely state as follows:

1. That Sri Vidya Educational Trust is a registered trust under the Trust Act.
2. That Sri Vidya Educational Trust is of Non-Proprietary Character.
3. That Romasha International School is being run as a community service and not as a business and that commercialization does not take place in the school in any manner whatsoever.
4. That no part of income from the institution is being and will be diverted to any individual in the Trust/Society/Company/School Management Committee or to any other person/entity. The saving, if any, after meeting the recurring and non-recurring expenditure and contributions to development, Depreciation and contingency funds, will be further utilized for promoting the school and extending the cause of education in the same school only.
5. That school is not paying any charges towards using name, motto, logo or any other non-academic activities to any other institution, organization or body.
6. That the school will not open classes under CBSE pattern particularly class IX/X/XI/XII and will not use CBSE name in any manner without obtaining affiliation.
7. That the principal and correspondent/Manager of the school have individually gone through the provisions contained in the affiliation & examination byelaws and the circulars issued by the Board from time to time. The school undertaken abide by the provision contained in the affiliation & examination bye-laws to directions issued from time to time and the laws of the land.
8. That the school will ensure compliance of all statutory requirements like EPF, ESI and Labour Laws etc. with respect to the school and staff of the school.
9. That the school will ensure that the Building Safety, Fire Safety, Water safety, Health and Hygiene certificate are being issued or renewed by the concerned municipal or state authorities from time to time as per the prescribed term.
10. That the school will ensure that all required infrastructure is available with the school before starting classes.
11. That the school will ensure that sufficient number of qualified teacher as per the provision contained in affiliation bye-Laws is available with the school before starting classes.
12. That the school will follow the provisions related to fee contained in affiliation bye-laws and will disclose the details of the fee to the students/parents every year before start of session without resorting to any hidden charges in the heads of the fee.
13. That the school will not coerce any student/parent to buy books/stationary/uniform from any particular shop.
14. That the school shall strive to make efforts for conservation of environment.



15. That the school will ensure that the school fulfill all essential requirement before applying for affiliation and will fulfill all other condition post affiliation and comply with all the general rules as given in the affiliation bye-laws or notified from time to time.
16. That the school will not start CBSE pattern classes without submitting a commencement certificate to the effect that the school has complied with all the condition imposed by CBSE and the post-affiliation condition contained in affiliation bye-laws along with general rules.

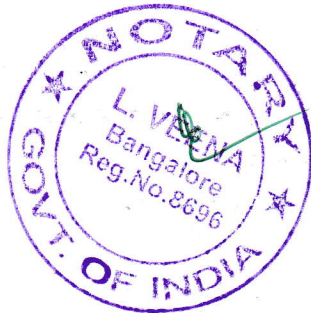
